The 22<sup>nd</sup> Annual General Meeting (AGM) of the members of Tarini International Limited ('the Company') was held on Wednesday, 30<sup>th</sup> September, 2021 at 11:00 AM at its registered office Situated at D-2, 1<sup>st</sup> Floor, Amar Colony, Lajpat Nagar – IV, New Delhi – 1100 24.

During the meeting the Standard Operating Procedure (SOP) prescribed by the Ministry of Home Affairs, Govt of India, such as social distancing, usage of proper mask and sanitization were followed.

Mr. Vakamulla Chandrashekhar (the Chairman) chaired the meeting and welcomed the members at the 22<sup>nd</sup> AGM of the Company. The Chairman called the meeting to order and as the requisite quorum was present, he conducted the proceedings of the meeting.

With the approval of the members present, the Notice convening the Meeting, Directors Report and Audited Financial Statements (Standalone & Consolidated) for the financial year ended March 31, 2021 and Auditors Report was taken as read by the Chairman. The Company secretary read the observations of the Statutory Auditor and Secretarial Auditor and the reply of the Board on this account for the benefits of the members.

The Chairman delivered his speech and addressed the shareholders on the performance of the Company. Thereafter, the Chairman answered the queries raised by the Members and the items of business as per the notice of the AGM were transacted at the Meeting.



The Chairman informed to the shareholders that as per the Notification issued by the Ministry of Corporate Affairs dated 19 March, 2015 read with Companies (Management and Administration) Rules, 2014, Companies covered under Chapter XB of the SEBI (ICDR) regulations, 2009 are exempted from providing e-voting facility to its shareholders and hence the Company is not providing e-voting facility to all shareholders of the Company.

The Chairman advised the Shareholders/Members who hold shares in physical form to send the share certificates to Link Intime India Pvt Ltd, for dematerialisation as per SEBI Notification related to Physical Share Transfer dated June 8, 2018 it has amended Regulation 40 of SEBI (Listing Obligation and Disclosure Requirements) Regulations 2015, mandating transfer of securities only in dematerialized form. Accordingly, the company would not be able to accept requests for transfer of securities unless the securities are held in Dematerialized form with effect from December 5, 2018.
